Notification of change to the underlying fund of BNP Paribas Brazil Equity (H23) (the "Affected Investment-linked Fund")

We are writing to you as a policyholder of one of the above named Schemes, of which your policy or contract holds units the FPIL Affected Investment-linked Fund listed above. We have been notified by the Board of Directors of BNP Paribas Funds (the "Company") of the following upcoming change which affects the underlying fund of the Affected Investment-linked Fund. This change will take effect from **1 August 2025** (the "Effective Date").

Appointment of new investment management company of the underlying fund of the Affected Investmentlinked Fund

The Company has advised that it has undertaken a review of investment management capabilities across the entities of the BNP Paribas group. As a result, *BNP Paribas Asset Management Singapore Limited* will be appointed as a new investment manager of the underlying fund of the Affected Investment-linked Fund from the Effective Date.

There will be no change to the investment objective or policy of the underlying fund of the Affected Investmentlinked Fund as a result of the appointment. It will not materially change the features and overall risk profile of the underlying fund of the Affected Investment-linked Fund, and there will be no change in the operations or the manner in which it is managed.

The Company has advised that the change of the investment manger will not result in any change in fees level or costs in managing the underlying fund of the Affected Investment-linked Fund, and no costs and/or expenses will be incurred in connection with the change.



This change will happen automatically within your policy or contract and you do not need to take any action.

Should you wish to switch your existing investment out of the Affected Investment-linked Fund, or to redirect future regular premiums (if any) to a different investment-linked fund, you are free to do so, without charge, by completing a Switch/Redirection instruction form and returning it to our Hong Kong office, a copy of which is available on request.
